**SUPPLEMENTAL DISCLOSURE OF GIBSON, DUNN & CRUTCHER, LLP
REGARDING FIRM LOBBYING ACTIVITIES (FEDERAL, STATE, AND LOCAL)
IN THE TEN YEARS PRECEDING MARCH 2011**

- **Federal Lobbying**
 - A number of Gibson Dunn attorneys are, or have been in the past ten years, registered as federal lobbyists.
 - The searchable database maintained by the U.S. House of Representatives pursuant to the Lobbying Disclosure Act (<http://disclosures.house.gov/ld/ldsearch.aspx>), displays 245 results for Gibson Dunn attorneys registering as lobbyists on behalf of clients such as The Boeing Company; Ticketmaster Entertainment, Inc.; General Electric; and the U.S. Chamber of Commerce. (Attached is an excerpt from the database)
 - The searchable database maintained by the U.S. Senate pursuant to the Lobbying Disclosure Act (http://www.senate.gov/legislative/Public_Disclosure/LDA_reports.htm), displays 637 results for Gibson Dunn attorneys registering as lobbyists on behalf of clients such as Dollar Bank; Hoffman-Laroche, Inc.; I-Flow Corporation; and Wal-Mart Stores, Inc. (Attached is an excerpt from the database)
 - Gibson Dunn attorneys who are registered as federal lobbyists, or who have been registered in the past ten years, include but are not limited to Michael Bopp, Theodore Olson, Richard Zimmer, William Kilberg, John Olson, Amy Goodman, Eugene Scalia, and Mel Levine.
 - George Brown, Dan Kolkey, Matthew Kahn, and Kahn Scolnick have never been registered as federal lobbyists.

- **State Lobbying in California**
 - The California Secretary of State's searchable lobbying database (<http://cal-access.ss.ca.gov/Lobbying/Firms/>), displays zero results for Gibson Dunn registering as a lobbying firm between March 2001 and March 2011.
 - George Brown, Dan Kolkey, Matthew Kahn, and Kahn Scolnick have never been registered as lobbyists with the State of California.

- **Local Lobbying in California**
 - A number of Gibson Dunn attorneys (including Amy Forbes, Maurice Suh, and Christopher Chorba) are (or were in the past ten years) registered as local lobbying representatives with the City of Los Angeles, on behalf of such clients as Schindler Elevator Corporation; the Los Angeles Tennis Club; and the Fashion Institute of Design and Merchandising.
 - George Brown, Dan Kolkey, Matthew Kahn, and Kahn Scolnick have never been registered as local lobbyists in California.

- **State and Local Lobbying *Other than California***
 - In the past ten years, Gibson Dunn attorneys have registered as lobbyists with the State of New York on behalf of such clients as Madison Square Garden, L.P. and Battery Park Homeowners Coalition.

- In the past ten years, Gibson Dunn attorneys have registered as lobbyists with the City of New York on behalf of such clients as Madison Square Garden, L.P.; Titan Outdoor, Inc.; and Krasdale Foods, Inc.
- Before joining Gibson Dunn in 2010, partner Robert Walters was registered to lobby in Texas from 2008 through 2010, while serving as general counsel of a private company. Since joining Gibson Dunn in 2010, Mr. Walters is no longer registered as a lobbyist in Texas.
- George Brown, Dan Kolkey, Matthew Kahn, and Kahn Scolnick have never been registered as state or local lobbyists in any jurisdiction.
